HANCOCK COUNTY BOARD OF SUPERVISORS October 19, 2020

Garner, Iowa

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of October 12, 2020 meeting were read and approved.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following: Signed and approved the following lease agreements for Secondary Road ground: 52.34 acre farm located in the Southeast Quarter (SE ¼) of section 26, Liberty Township with Grant and Brenda Anderson, 24.64 acre pasture farm located in the Southeast Quarter (SE ¼) of section 26, Liberty Township with Grant and Brenda Anderson, approximately 15 acre hayground farm located in the SE corner of the Southeast Quarter (SE ¼) of section 26, Liberty Township with Grant and Brenda Anderson, 52.48 acre farm located in the East half (E ½) of the Northeast Quarter (NE ¼) of section 11, Crystal Township with Brad Sorenson, and 5.8 acre farm located in the Southeast Quarter (SE ¼) of section 14, Garfield Township with Tucker Barickman. Signed Iowa Department of Transportation Agreement for Surface Transportation Block Grant Program Federal-aid Swap Project. Signed the final plans for project FM-C041(129)—55-41, FM-C041(130)—55-41, L-128—73-41. Reviewed and accepted the County Social Services audit report for fiscal year ending June 30, 2019.
