

PUBLIC NOTICE

OFFICIAL NOTICE BEFORE THE UTILITIES BOARD OF THE STATE OF IOWA TO THE CITIZENS OF HANCOCK COUNTY:

Notice is given that Corn Belt Power Cooperative, Humboldt, Iowa, pursuant to Iowa Code chapter 478 (2019), has filed a petition with the Utilities Board (Board) for an amendment to a franchise to erect, maintain and operate an electric transmission line setting forth the following as the maximum voltage, starting points, routes, and termini of the proposed lines:

69,000 Volts Nominal (72,500 Volts Maximum) Electric Trans- mission Line Hancock County, Iowa KLEMMER-GARNER RELOCATE

The south endpoint of this line is at a point of interconnection with Corn Belt Power Cooperative's existing 69kV transmission line located near the South Quarter Corner of Section 6, T-94N, R-23W of the 5th P.M., Hancock County, Iowa; and the south terminus of this line is Corn Belt Power Cooperative's Klemme Switching Station located near the Northeast Corner of the Northwest Quarter of Section 7, T-94N, R-23W of the 5th P.M., Hancock County, Iowa.

The north endpoint of this line is at a point of interconnection with Corn Belt Power Cooperative's existing 69kV transmission line located near the Northeast Corner of the Southeast Quarter of the Southwest Quarter of Section 32, T-95N, R-23W of the 5th P.M., Hancock County, Iowa; and the north terminus of this line is Corn Belt Power Cooperative's Liberty Substation located near the Southeast Corner of the Northwest Quarter of Section 29, T-96N, R-23W of the 5th P.M., Hancock County, Iowa.

The south terminus of this line is Corn Belt Power Cooperative's Klemme Switching Station located near the Northeast Corner of the Northwest Quarter of Section 7, T-94N, R-23W of the 5th P.M., Hancock County, Iowa. The south endpoint of this line is at a point of interconnection with Corn Belt

Power Cooperative's existing 69kV transmission line located near the South Quarter Corner of Section 6, T-94N, R-23W of the 5th P.M., Hancock County, Iowa.

Thence east, in public right of way, within the north boundary of 150th Street, along the south section lines of Section 6 and Section 5, T-94N, R-23W, crossing the public road right of way of Taft Avenue to a point located within the north boundary of 150th Street, approximately 502 feet east of the Southwest Corner of said Section 5, said Township and Range; 0.60 mile.

Thence southeast, in public right of way, crossing the public road right of way of 150th Street, to a point located within the south boundary of 150th Street, approximately 735 feet east of the Northwest Corner of Section 8, T-94N, R-23W; 0.04 mile.

Thence east, in public right of way, within the south boundary of 150th Street, along the north section line of Section 8, T-94N, R-23W, to a point located within the south boundary of 150th Street, approximately 29 feet west of the North Quarter Corner of said Section 8, said Township and Range; 0.35 mile.

Thence north, in public right of way, within the west boundary of Taylor Avenue, along the east section line of the Northwest Quarter of Section 8, T-94N, R-23W, and the east section line of the West Half of Section 5, T-94N, R-23W, crossing the public road right of way of 150th Street, to a point located within the west boundary of Taylor Avenue, approximately 29 feet west and 29 feet south of the North Quarter Corner of said Section 5, said Township and Range; 0.97 mile.

Thence northeasterly, in public right of way, across the Northeast Quarter of the Northwest Quarter of Section 5, T-94N, R-23W, and on private right of way, across the Southeast Quarter of the Southwest Quarter of Section 32, T-95N, R-23W, crossing the public road right of way of 160th Street, to a point located approximately 225 feet north of the South Quarter Corner and on the north-south center section line of said Section 32, said

Township and Range; 0.05 mile.

Thence north, on private right of way, along the north-south center section line of Section 32, T-95N, R-23W, to a point located near the Northeast Corner of the Southeast Quarter of the Southwest Quarter of said Section 32, said Township and Range; 0.21 mile.

The north endpoint of this line is at a point of interconnection with Corn Belt Power Cooperative's existing 69kV transmission line located near the Northeast Corner of the Southeast Quarter of the Southwest Quarter of Section 32, T-95N, R-23W of the 5th P.M., Hancock County, Iowa; and the north terminus of this line is Corn Belt Power Cooperative's Liberty Substation located near the Southeast Corner of the Northwest Quarter of Section 29, T-96N, R-23W of the 5th P.M., Hancock County, Iowa.

The total distance of this 69,000 volts line is approximately 2.22 miles.
