HANCOCK COUNTY BOARD OF SUPERVISORS

November 30, 2020

Garner, Iowa

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of November 23, 2020 meeting were read and approved.

A public hearing was held on the permit application for Pin Oak Farms, LLP, for increase in animals only in an existing swine confinement facility located in section 33, Ellington Township. Certification that publication as to the date and time of the hearing was on file in the Auditor's Office. Those present for the hearing were Supervisors Tlach, Greiman, and Rayhons, Auditor Michelle K. Eisenman, and Hancock County Engineer Jeremy Purvis. Present from the public were Bob Kern, present via Go to Meeting: Kent Krause, Mitch Baum and Rob Hillesland-Globe Gazette. Kent Krause spoke in regards to the application. There were no written or oral comments for or against the application. On motion by Supervisor Tlach to close the public hearing, seconded by Supervisor Rayhons. All ayes. On motion by Supervisor Rayhons, seconded by Supervisor Tlach and carried, the Board voted to unanimously approve the application. This recommendation will be forwarded onto the Iowa Department of Natural Resources, as defined by law.

There were no written or oral comments for or against the application. On motion by Supervisor Rayhons to close the public hearing, seconded by Supervisor Tlach. All ayes. On motion by Supervisor Tlach, seconded by Supervisor Rayhons and carried, the Board voted to unanimously approve the application. This recommendation will be forwarded onto the Iowa Department of Natural Resources, as defined by law.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following: Signed Memorandum of Understanding with The Office of the Chief Information Officer of the State of Iowa (OCIO) for enhanced security services. Approved Hancock County Payee Program effective December 1, 2020.
