Notice is hereby given to the qualified electors in Hancock County, Iowa, that the PRIMARY ELECTION in Hancock County, State of Iowa, will be held on Tuesday, June 2, 2020 at the following polling places in the combined voting precincts of Hancock County. The polls will be from 7:00 A.M. and will close at 9:00 P.M. The polling places are listed below. Voters must vote at their assigned precincts. Commissioner of Elections in compliance with the laws of Iowa.

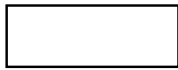
Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by June 8, 2020. Election Day Registrant attestors must provide an approved form of identification.
