

PROCEEDINGS: Hancock County Board of Supervisors

HANCOCK COUNTY BOARD OF SUPERVISORS January 18, 2021 Garner, Iowa

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of January 12, 2021 meeting were read and approved.

On motion by Supervisor Tlach, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Approved Hancock County policy regarding compensation for damages for drainage district projects for 2021. County Treasurer's semi-annual report for the period of July 1, 2020 to December 31, 2020. Appointed Florence Sis Greiman to chair the committee for interior courthouse repairs and given authority to appoint other members to the committee.

On motion by Supervisor Greiman, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following: Approved Hancock County Secondary Road right of way acquisition policy for 2021. Approved the Request for Qualifications for Professional Services for Hancock County Courthouse Improvements Project and reappoint Blake Norman, County Attorney, Jeremy Purvis, County Engineer, and Jerry Tlach, County Supervisor to accept, review, and report the findings of the request for qualifications back to the Board of Supervisors.
