The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of February 16, 2021 meeting were read and approved.

On a joint teleconference with Cerro Gordo County Board of Supervisors, Chris Watts, Tim Latham, and Casey Callanan, Absent: none; and Hancock County Board of Supervisors, Florence (Sis) Greiman, Gary Rayhons, and Jerry Tlach, Absent: none; motion by Supervisor Callanan, seconded by Supervisor Tlach, and carried unanimously, the Joint Board gave approval to the following: Tentatively approved Engineer Kent Rode's annexation of lands report for Joint Drainage District no. 13-128 and set the date and time for hearing with landowners on annexation of lands report for April 12, 2021 at 11:00 a.m. in the Basement Meeting Room of the Law Enforcement Center. On motion by Supervisor Greiman, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following: Hiring of Matthew Gerdes, Deputy Sheriff, effective March 15, 2021 at \$55,500 per year (\$25.57 per hour). Approved the quote for a printer for Board of Supervisor's office from Counsel, Harlan, Iowa in the amount of \$875 and a monthly maintenance agreement in the amount of \$20.

On motion by Supervisor Tlach, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Revised the illness reporting section for employees who have completed the COVID-19 vaccine series of the Hancock County, Iowa Infectious Disease Action Plan COVID-19 Pandemic January 4, 2021 effective January 1st, 2021 amended February 22, 2021. Eight-month class C liquor license with outdoor service for Ryco Promotions, LLC doing business as Hancock County Speedway effective March 28, 2021.
