The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of May 22, 2020 meeting were read and approved.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following: Terms of service with Renner & Birchem, PC in the amount of \$15,600 for fiscal year ending June 30, 2020.

Amended Resolution No. 2020-020

Approval of Fiscal Year 2019-2020 Budget Amendment # 1

WHEREAS, the Hancock County Board of Supervisors has considered the proposed Fiscal Year 2019-2020 county budget amendment, and

WHEREAS, a public hearing concerning the proposed county budget amendment #1 was held on May 11, 2020,

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Hancock County that the county budget amendment #1 for Fiscal Year 2019-2020, as set forth in the budget summary, is hereby adopted and the Hancock County Auditor is directed to file said budget and to establish accounting records in accordance with the below listed schedule.

Revenues:

Intergovernmental from 4,328,970 to 4,533,121

Licenses and Permits from 21,400 to 27,400

Use of Money and Property from 205,657 to 211,018

Miscellaneous from 111,140 to 237,931

Total Revenues increased from 13,740,159 to 14,082,462

Expenditures:

Physical Health & Social Services from

449,902 to 433,402

County Environment & Education from 726,793 to 748,593

Roads & Transportation from 6,923,429 to 7,163,429

Government Services to Residents from 598,145 to 601,645

Administration from 1,551,695 to 1,556,695

Capital Projects from 930,000 to 690,000

Total Expenditures increased from 16,149,035 to 16,162,835

BE IT FURTHER RESOLVED that the Chairperson and the County Auditor be and are hereby authorized to sign the approved Fiscal Year 2019-2020 county budget amendment #1. This amendment is necessary to correct a scrivener's error excluding the reduced expenditure of Capital Projects in the resolution. The reduction in expenditures for Capital Projects was included in the County Budget Amendment #1 and in the total expenditures amount of the original resolution.

**RESOLUTION NO. 2020-022
TEMPORARY ROAD CLOSING**

As per Section 306.41 Code of Iowa be it resolved that the Board of Supervisors of Hancock County hereby declare closed temporarily the following roads in Hancock County due to construction, reconstruction, maintenance or natural disaster. This resolution shall become effective upon placement of temporary road closure signs and shall expire when the said temporary signs are removed upon completion of said project.
