HANCOCK COUNTY BOARD OF SUPERVISORS May 28, 2020 Garner, Iowa

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman and Jerry J. Tlach present. Absent: Gary Rayhons.

RESOLUTION No. 2020-023 RESOLUTION REGARDING JOINT DRAINAGE DISTRICT JOINT DRAINAGE DISTRICT NO. 46-3 LATERAL 37

The Joint Board of Supervisors of Kos-suth and Hancock Counties hereby prepare to levy a special assessment on the above Joint Drainage District.
