The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of July 7, 2020 meeting were read and approved.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following: Signed ICAP (Iowa Communities Assurance Pool) Statement of Action Taken form. Direct County Attorney to prepare notifications of termination of Wright-Hancock County Engineer Share Agreement to Wright County and Adam Clemons, P.E.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following: Awarded the bid for phone system for Hancock County to SkyBlue Solutions, LLC in the amount of \$19,083.73. Quarterly reports of the Hancock County Recorder and Hancock County Sheriff for the period ending June 30, 2020. Change maintenance director position from hourly rate to salary at \$51,000 per year effective July 19, 2020. Pay out Kevin Hoeft 120 comp hours earned prior to July 19, 2020 on July 23, 2020 pay date. Hiring of Jeremy Purvis, full-time County Engineer pending approval of contract for employment of County Engineer and background check. On motion by Supervisor Rayhons,

WHEREAS, IT IS DESIRED TO MAKE APPROPRIATIONS FOR EACH OF THE DIFFERENT OFFICERS AND DEPART-MENTS FOR THE FISCAL YEAR BE-GINNING JULY 2020, IN ACCORDANCE WITH SECTION 331.434, SUBSECTION 6, CODE OF IOWA

NOW, THEREFORE, BE IT RE-SOLVED by the Board of Supervisors of Hancock County, Iowa, as follows:

SECTION 1. The amounts itemized by fund and by department or office are hereby appropriated from the resources of each fund as follows: Board of Supervisors - \$496,342; County Auditor -\$489,256; County Treasurer - \$457,698; County Attorney - \$262,160; County Sheriff - \$1,431,881; County Recorder -\$210,567; Township Officers - \$11,709; Sanitary Disposal Services - \$65,000; Secondary Road - \$7,288,978; Veterans Affairs - \$51,533; Conservation Board - \$474,200; Public Health Services - \$280,070; Social Services -\$60,891; Medical Examiner - \$31,700; District Court - \$1,300; Communications - \$444,752; Fairgrounds - \$34,500; Libraries - \$130,000; General Services -\$372,169; Data Processing - \$347,340; Zoning Commission - \$8,870; Home Care Health Services - \$24,695; Law Enforcement Center - \$12,500; Mental Health Administration – \$326,360; Juvenile

Probation - \$31,500; Emergency Management - \$45,337; Non-departmental -\$2,635,304; Total = \$16,026,612.

SECTION 2. Subject to the provisions of other county procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or obligations from the itemized department effective July 1, 2020.

SECTION 3. In accordance with Section 331.437, Code of Iowa, no department or officer shall expend or contract to expend any money or incur any liability or enter into any contract which by its terms involves the expenditure of money for any purpose in excess of the amounts appropriated pursuant to this resolution.

SECTION 4. If at any time during the 2020-2021 budget year the auditor shall ascertain that the available resources of a department for that year will be less than said department's total appropriations, she shall immediately so inform the board and recommend appropriate corrective

SECTION 5. The Auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which account shall indicate the amount of the appropriation, the amounts charged thereto, and the unencumbered balance. The Auditor shall report the status of such accounts to the applicable departments and officers quarterly during the 2020-2021 budget year.

SECTION 6. All appropriations authorized pursuant to this resolution lapse at the close of business June 30, 2021.

The original resolution was adopted by the Board of Supervisors in Hancock County, Iowa, on June 29, 2020. The amended resolution is necessary to correct a scrivener's error for the Department of Library from \$130,00 to \$130,000. The total of the appropriations did not change.
