The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of June 29, 2020 meeting were read and approved.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following: Quarterly report of the Hancock County Auditor for period ending June 30, 2020. Five-day class B beer permit for Hancock County Agricultural Society (Three Seasons Building), Britt, Iowa, with outdoor service and Sunday sales beginning July 28, 2020. Five-day class B beer permit for Hancock County Agricultural Society (Old Skating Rink), Britt, Iowa, with outdoor service and Sunday sales beginning July 28, 2020. Amendment to the Wright-Hancock County Engineer Share Agreement.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons and carried

unanimously, the Board gave approval to the following: Five-day class B beer permit for Hancock County Agricultural Society (Old Skating Rink), Britt, Iowa, with Sunday sales beginning July 23, 2020. Five-day class B beer permit for Hancock County Agricultural Society (Show Ring Area), Britt, Iowa, with outdoor service and Sunday sales beginning July 28, 2020. Five-day class B beer permit for Hancock County Agricultural Society (Tent south of Ag Museum), Britt, Iowa, with outdoor service and Sunday sales beginning July 28, 2020. Five-day class B beer permit for Hancock County Agricultural Society (Racetrack Saturday - Sunday), Britt, Iowa, with outdoor service and Sunday sales beginning August 1, 2020.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach, and carried, the Board authorized the County Auditor to issue checks for the claims on file this date, July 6, 2020. A full listing of all claims paid in July 2020 will be published in the July 20, 2020 minutes.
