Time and Place for Filing Sealed Proposals. Sealed bids for the work comprising the repair as stated below must be filed before 10:00 A.M. on September 10, 2020, in the office of the County Auditor, 855 State Street, Garner, Iowa.

Time and Place Sealed Proposals Will be Opened and Considered. Sealed proposals will be opened, and bids tabulated at 10:00 A.M. on September 10, 2020, in the Board Room of the Hancock County Board of Supervisors, for consideration by Drainage District Trustees at its meeting at 11:00 A.M. on September 14, 2020. The Drainage District Trustees reserves the right to reject any and all bids.

Time for Commencement and Completion of Work. Work on the improvement shall commence upon approval of the contract by the Trustees, and as stated in the Notice to Proceed. All work under the Contract must be substantially complete on or before May 1, 2021. Damages in the amount of \$500.00 per day will be assessed for each day the work remains incomplete.

Bid Security. Each bidder shall accompany its bid with bid security, as defined in Section 468.35 of the Iowa Code in the amount equal to five percent of the total amount of the bid.

Contract Documents. Copies of the project documents are available for a price of \$25 per set. This fee is refundable, provided the plans and specifications are returned complete and in good usable condition, and they are returned within fourteen (14) calendar days after the award of the project. Preference of Products and Labor. Preference shall be given to domestic construction materials by the contractor, subcontractors, material, men, and suppliers in performance of the contract and further, by virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes. Failure to submit a fully completed Bidder Status Form with the bid may result in the bid being deemed nonresponsive and rejected.

Sales Tax Exemption Certificates. The bidder shall not include sales tax in the bid. The County Auditor will distribute tax exemption certificates and authorization letters to the Contractor and all subcon-

tractors who are identified. The Contractor and subcontractor may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the Contract.

Payment for work done will be in accordance with estimates approved monthly by the Engineer and in Drainage Warrants issued by the Drainage District, which if registered and stamped "not paid for want of funds", shall bear interest at a rate fixed by the Trustees not to exceed the maximum set by law in accordance with Chapter 468 of the Code of Iowa, as amended. The Trustees reserves the right to issue Drainage District Improvement Certificates pursuant to Chapter 468 of the Code of Iowa, as amended, which certificates may be given in exchange for outstanding warrants issued to the Contractor or to the holder thereof. Said warrants to be surrendered, if called by the Trustees, in exchange for Drainage District Improvement Certificates which shall be taken by the Contractor or holder at par and shall bear interest at a rate fixed by the Trustees not to exceed the maximum set by law in accordance with Chapter 468 of the Code of Iowa, as amended.

Progress payments will be made in an amount equal to ninety percent (90%) of the work completed. Final payment will be made not less than thirty (30) days after completion of the work and acceptance by the Board, subject to the conditions and in accordance with the provisions of Chapter 468 of the Code of Iowa, as amended.

PROJECT DESCRIPTION: This project consists of two separate construction divisions.

Division 1 consists of construction of approximately 781 linear feet of 18" diameter RCP tile, 1,947 linear feet of 15" diameter RCP tile, and 2,197 linear feet of 12" diameter RCP tile, connections of both existing private tile and district facilities to the new tile. Installation of two circular area intakes, one with a 24" diameter riser and the second with an 18" diameter riser.

Division 2 consists of construction of approximately 120 linear feet of 16" diameter steel pipe, jack and bored under a Hancock County roadway, rural seeding and fertilization, safety closures, and traffic control.

All divisions thereof also include any and all other miscellaneous items related thereto.

Bidders must bid on all division to be considered for award. The Board of Supervisors acting as Trustees can select any combination of Divisions which is in the best interest of the drainage district and secondary roads department for award.
