OFFICIAL COUNCIL PROCEEDINGS: City of Klemme

Klemme City Council Proceedings Monday June 1, 2020

The Klemme City Council met at the regular meeting on Monday June 1, at 6:30 PM, Community Room, City Hall.

The meeting was called to order by Mayor Blank. Present: Trampel, Wolf, Crotty and Taft.

Additions to the agenda were, Covid Update, Main Street Projects and Clean Up.

Taft made a motion to accept the agenda. Trampel seconded the motion. Motion carried.

Taft made a motion to approve the minutes of the previous meetings. Crotty seconded the motion. Motion carried.

Taft made a motion, with a second from Crotty, to approve the payment of the bills, as presented, with the exception of In-Step Flooring. Motion carried.

The Sheriff's Report was reviewed.

The Mayor opened the public hearing for 2019/2020 Budget Amendment. There were no public opinions on the 2019/2020 proposed amendment. The Mayor then closed the public hearing.

Trampel made a motion, with a second from Crotty, to accept Resolution #06-01-20 AMEND (AMENDING OF THE 2019-2020 BUDGET). Roll call vote was taken with Crotty, Wolf, Taft and Trampel voting ayes. Those voting nay were none. Motion carried.

Mayor Blank opened the public hearing on the issue of Vacation and Sale of Hancock Street and an Alley. There were no comments from the audience. Mayor Blank then closed the public hearing.

Councilmember Trampel introduced Ordinance No. 238 entitled Vacation and Sale of Hancock Street and Alley, and moved that the clerk read the same for the 1st time. Councilmember Crotty seconded the motion. Roll call vote was taken with Crotty, Wolf, Taft and Trampel voting ayes. Those voting nay were none.

The Mayor declared the motion carried. After reading by the Clerk, Councilmember Trampel made a motion to approve Ordinance No. 238 for the 1st time. Councilmember Taft seconded the motion. Roll call vote was taken with Crotty, Wolf, Taft and Trampel voting ayes. Those voting nay were none. The Mayor declared the motion carried. Councilmember Trampel moved that the rule requiring three separate readings of proposed Ordinance No. 238 be waived. Councilmember Crotty seconded the motion. Roll call vote was taken with Crotty, Wolf, Taft and Trampel voting ayes. Those voting nay were none. The Mayor declared the motion carried Councilmember Taft moved that Ordinance No. 238 be adopted. Councilmember Crotty seconded the motion. Roll call vote was taken with Crotty, Wolf, Taft and Trampel voting ayes. Those voting nay were none. The Mayor declared the motion carried, and that Ordinance No. 238 adopted and directed the Clerk to post copies of the Ordinance as required by

Taft made a motion to appoint David Abele to fill the council vacancy. Crotty seconded the motion. Those voting aye were Taft and Crotty. Those voting nay were Trampel and Wolf. Motion failed. Trampel made a motion to appoint Shannon Boge-Miller to fill the council vacancy. Wolf seconded the motion. Motion carried. Miller will serve until the next city election, unless a petition is filed to have an election.

Taft made a motion, with a second by Trampel to approve a beer permit for Klemme Townmart. Motion carried with all

Trampel made a motion, with a second by Crotty, to approve a cigarette permit for Klemme Townmart. Motion carried.

Kenneth Weiland, Public Works Director, was present at the meeting.

Weiland informed the council that the

drainage project on Frogslip worked great during the recent rains. Heartland had been in town and had submitted a street repair bid. Trampel made a motion to accept the bid for 9 repairs at a cost of \$10,167.30, along with allowing Weiland or Mayor Blank to approve others that might arise with a price limit not to exceed \$15,000.00. Motion carried.

Additions to the agenda were Covid Update, Weiland had reported that the City Park will open up again as allowed by state and will remove signs. City Clerk Rout will be opening up the clerk's office on July 6th. Was discussed to repaint the lines on Main Street, also cover up the front window of a building to help out the owner. The Mayor and City Clerk will be meeting to go over the list of junk vehicle letters that were sent, to see if any progress has been made. They will then contact the attorney, for advice on what the next action to take is to get them cleaned
