

# PROCEEDINGS: Klemme

## Klemme City Council Proceedings Monday July 6, 2020

The Klemme City Council met at the regular meeting on Monday July 6, at 6:30 PM, Community Room, City Hall.

The meeting was called to order by Mayor Blank. Present: Trampel, Wolf, Crotty and Boge-Miller. Absent Taft.

Trampel made a motion to accept the agenda. Boge-Miller seconded the motion. Motion carried.

Wolf made a motion to approve the minutes of the previous meetings. Boge-Miller seconded the motion. Motion carried.

Trampel made a motion, with a second from Crotty, to approve the payment of the bills as presented. Motion carried.

The Sheriff's Report was reviewed.

Cars on 1st Street were discussed. Council asked Public Works Director Weiland to mention to people parking along there to keep as close to their side as possible. Also cars driving faster than they should-option was to move one of our portable speed signs to that street, to get drivers attention.

Kenneth Weiland, Public Works Director, was present at the meeting. Weiland informed the council that the water leak on Frogslip had been repaired, was in the line to old concession stand. Heartland Asphalt had been in town and made the necessary repairs to the City streets that they had identified needing repair, they did a few extra spots while they were here, with the cost being the same as quoted. Council asked Weiland to check out some information on purchasing of a pay loader, with trade in value. Since we are starting the new budget year, the council told Weiland to go ahead and locate and update around 10 to 12 water shut off valves just like we did last year, starting with those that are behind on their bill.

Weiland also had gotten a quote from Iowa Lot Striping for painting of lines on Main Street, as requested by the council at the June meeting. After some discussion it was decided to wait until next spring as we are headed into August and winter will be here soon, so not to scrape off the new paint.

Junk and junk vehicles were discussed. As mentioned at the June meeting things were going to be moving forward. The legal process, along with information obtained by the Mayor, City Clerk and Public Works Director from meeting with the City attorney was addressed to everyone in attendance. This will be an ongoing process with more properties already being addressed and letters will be forth coming.

Trampel made a motion, with a second from Boge-Miller to adjourn. Meeting adjourned. Colleen Rout, City Clerk/Treasurer
